



Terms and Conditions for Photobooth Services

These Terms and Conditions ("Agreement") are entered into by and between Wooden Memory Photobooth, referred to as "Provider," and the undersigned customer referred to as "Customer," collectively referred to as the "Parties." This Agreement outlines the policies and terms for photobooth services at events or venues.

1. Service Duration:

- The service duration covers the time agreed upon for photobooth operation at the event. It does not include the setup or packing down of equipment, which will be done by the Provider outside of the agreed service hours.
- The specific service durations are:
 - Snapshot Starter Package: 2 hours.
 - Picture Perfect Package: 3 hours.
 - Memory Maker Deluxe Package: 4 to 5 hours.

2. Venue and Location:

- The Customer is responsible for ensuring a safe location for the photobooth within the venue.
- The photobooth setup should not obstruct any emergency exits or high-traffic areas within the venue.
- The Customer will be responsible for nominating a person to be contacted at the venue to coordinate the service and not disturb the Customer on their special day.

3. Electrical Connection:

- The Customer must provide a reliable electrical connection for the equipment to function correctly. The Provider will specify the power requirements in advance and will ensure all equipment is safety tagged and tested.

4. Parking and Equipment Transportation:

- The Customer is required to provide a spot close to the venue's entrance to facilitate the transportation of the photobooth equipment to and from the event location.



5. Cancellation Policy:

- In the event of a cancellation, the Customer must notify the Provider at least five (5) days before the scheduled event. Failure to do so will result in the forfeiture of the 50% advance payment, which is non-refundable.

6. Refund Policy:

- If the Customer cancels more than five (5) days before the event, the advance payment will be refunded minus a 10% administrative fee.
- No refunds will be issued for cancellations made less than five (5) days before the event.

7. Payment Terms:

- The total cost of the service is divided into two payments: 50% in advance and 50% on the day before the event begins.
- You should make the payment as specified by the Provider, and the service will not begin until the advance payment is received.

8. Damages:

- The Customer is responsible for any damage to the photobooth equipment during the event, caused by guests or any other factors. The Customer will be charged for the cost of repairs or replacements. The provider will ensure to create a safe area is created to provide the service in proper manners.

9. Photo and Video Usage:

- The Provider will use photos and videos taken at the event for promotional purposes unless otherwise agreed upon in writing with the Customer.

10. Liability:

- The Provider shall not be liable for any damages or injuries resulting from the use of the photobooth or any related equipment.

11. Entire Agreement:

- This Agreement constitutes the entire understanding between the Parties and supersedes all prior agreements and understandings, whether oral or written.

By accepting, the Customer acknowledges and agrees to these terms and conditions. The Provider and Customer shall be bound by the terms outlined in this Agreement.
